- Calvelli's would like to support PBR by offering 10% of dining receipts on a designated day of the week. Details to follow.



New Business:

- **Board Member/Officer Changes**
 - Devon Long and Alexia Locke have been sent official resignation papers. Their resignations were made via PBR Board Chat on October 16, 2017.
 - Pam Thurston was voted in by Joseph Gemayel and Lynn Perkins in the capacity of Board Member and Officer-Secretary.
 - Joe will continue to take care of the Treasurer's Report.
 - There was discussion about bringing on board Amy Neibert. Vote unanimously approved for Amy to serve as a Board Member by Joseph Gemayel, Lynn Perkins and Pam Thurston.
- **Reaching out to Homeless Vets**
Joe attended Homeless Connect in Lapeer on November 2nd and met Blue Water and Battle Buddy. They will get back to him.
- **Non-Profit Status**
Our application was kicked back for additional information. The accountant had a personal crisis and left. Joe will contact him tomorrow. If we don't hear anything in 2 weeks we will pursue other avenues.

- **Newsletter**
Joe has a sample newsletter he will email to us for review
- **Email/Donor List**
Joe will take care of this. We have a list from the last two Rucks. He will post on Facebook letting everyone know to make a request to be put on our email list.
- **Future Events**
 - 2 Raffles for 2018 (need 3 months to advertise)
 - Ruck September 8th, 2018 (would like to send out packets in March hopefully under our own non-profit; if not, then we will partner with Mission 22 again. Last year we raised 5K; this year we will need an add'l 10K to cover the cost of MDOT. We are planning on advertising early in the newspaper, flyers, on the radio)
 - Theater/Play – partner up with a local high school and do a play about the history of our flag and our National Anthem. Contact drama teacher and maybe split admission cost 50/50 with school and PBR.
 - Spring Gala in 2019
- **Standard Operating Procedure (SOP)**
All future events will have a timeline established to better assist volunteers carry out their duties efficiently and to avoid miscommunication.
- **Checks/Bank Accounts**
 - Lynn will check with Sam's Club on getting a new register/check writing system; we would like 4 separate bank accounts:
 - OPERATIONS: Utilities and other overhead
 - EVENTS
 - CAPITAL FUND: Savings, real estate
 - GENERAL FUND: Our current business account, petty cash
- **Movie Donation**
Plans to make a donation to the movie "A Combat Veteran" have been scratched
- **Meeting Location Change**
In an effort to increase attendance, our next meeting will be held at Greg's in Metamora. The thought is that a public place with food may draw more interest.
- **Closed Board Group**
 - To define who we help...WE WILL HELP ANY VETERAN...no matter race, religion, gender, honorable or dishonorable discharge. As long as they are a verified veteran (DD 214).
 - Classy.com payment is coming up. We can pay \$750/quarter or the full amount. Joe personally paid 3K last year to them.
