## **CALL TO ORDER/ROLL CALL:**

The transfer of "Midwest Veterans Care Foundation", (MVCF) Tax ID #452974556, will become effective Monday, March 26, 2018, and will operate under PBR. Everything will be finalized with their board on March 30<sup>th</sup>. Rudy explained that even though we are all volunteers we must take at least a small wage even if we donate it all back to the group. Since we will be a 501C3, we are allowed to hold one raffle every quarter 4 day event max. He told us how important it was to keep impeccable, clear records and to be especially careful with documenting all fundraising and expenditures. Also, to focus on our main goal which is veteran housing. Rudy concluded and left the meeting.
- Nicole Gauthier of Lapeer Veteran's Navigator joined us to discuss her documentary "Project 22" which is about veteran suicide. It is 92 minutes long and delves into alternative treatments other than medication. She is looking for a venue to show her DVD (there is a trailer available online). The American Legion is \$100 per hour plus \$100 cleaning and set-up. She thinks she would need it for about 4 hours. Nicole left after her presentation. We will discuss helping her at a later date.
