Hello,

I am a single father of two girls. I was off for quite a while due to covid. I was not on unemployment as I had money put back. That was drained and I managed to pay up on my rent for the past 5 months and groceries and things they needed. I am responsible for rent, utilities, all the girls needs as well as mine. Groceries, gas, insurance are also my responsibility. I am employed full time again I just am struggling to catch up on what accrued during the pandemic. I am thankful for any assistance the girls and I can get. The amounts of what I need to get caught up to be back on track are 315 for electric and 500 for rent. I have not yet received a notice from my landlord and am only owing this month for rent. My ex claimed the girls on her taxes and she wasn't supposed to so I had my return and stimulus rejected. I had to fight it and send in a paper return to be audited. That is still being processed so I never received that income either. I hope you're able to help and thank you and God bless.
